

PREVENTION OF VIOLENCE IN SPORTS EVENTS
(Law 10/1990, dated 15 October; Art. 66, 67 y 68)

WHAT THE GENERAL PUBLIC MUST KNOW AND STRICTLY COMPLY WITH:

THE INTRODUCTION OR THE EXHIBITION OF BANNERS, SYMBOLS, EMBLEMS OR TEXTS THAT COULD ENCOURAGE VIOLENCE ARE STRICTLY PROHIBITED.

NO WEAPONS OR ANY TYPE MISSILES ARE PERMITTED.

THE PUBLIC SALE OR DISTRIBUTION/INTRODUCTION OF ALCOHOL IS PROHIBITED.

NO FIRECRACKERS, SMOKE OR NOISE BOMBS OR FIREWORKS OF ANY NATURE ARE PERMITTED.

ANY PERSON UNDER THE INFLUENCE OF ALCOHOL, NARCOTICS, DRUGS, STIMULANTS OR ANY OTHER SIMILAR SUBSTANCE WILL BE DENIED ACCESS TO THE STADIUM.

THE ENTRANCE IS PROHIBITED TO ANY PERSON THAT HAS BEEN SANCTIONED WITH THE PROHIBITION FROM ACCESS TO ANY EVENT, UNTIL THE SANCTION HAS BEEN LIFTED.

ANY PERSON WHO INFRINGES THE ABOVE RESTRICTIONS WILL BE PUNISHED BY THE GOVERNMENT AUTHORITIES.

THE ACQUISITION OF THIS TICKET MEANS THE ACCEPTANCE OF THE FOLLOWING CONDITIONS:

THE ORGANIZATION IS NOT RESPONSIBLE FOR THE TICKETS WHICH HAVE NOT BEEN ACQUIRED AT THE OFFICIAL POINT OF SALE. ALL TICKETS WHICH HAVE BEEN ALTERED RIPPED OR SHOW SIGNS OF FALSIFICATION WILL AUTHORIZE THE ORGANIZER TO PREVENT ITS CARRIER FROM THE ACCESS TO THE STADIUM.

THE FILMING, RECORDING OR REPRODUCTION OF ANY KIND IS PROHIBITED INSIDE THE STADIUM, EXCEPT FOLLOWING EXPRESS AUTHORIZATION BY THE ORGANIZER.

WHEN ENTERING THE STADIUM, THE PUBLIC MAY BE SUBJECTED TO A SEARCH AS ACCORDING TO THE LAW, NOT ALLOWING THE ENTRANCE OF OBJECTS THAT CAN BE CONSIDERED DANGEROUS BY THE ORGANIZATION OR ARE PROHIBITED BY THE RULES IN FORCE.

ONCE THE TICKET HAS BEEN ISSUED, IT MAY NOT BE RETURNED OR EXCHANGED.

ANY FORM OF AMBUSH COMMITTEE RESERVES THE RIGHT TO TAKE APPROPRIATE LEGAL ACTION AGAINST ANY PERSONS CONTRAVENING THESE RULES.

THE ORGANIZATION RESERVES THE RIGHT TO ADMISSION.
